Bullseye – 11/11 Veteran's Pistol & Rifle match; Starts at 9:00, guns and ammo available, electronic targets, room for 20, 12 currently signed up

Cowboy Action - No report

High Power – AR15 match held on 10/7; 12 shooters, one match winner with 783-28x, Ayden Unger. Two juniors, last match of the year Hunter Ed – No report

Juniors - Seven shooters on 11/3; team is shaping up with good things to come

Ladies – 3<sup>rd</sup> Annual Spooky Shoot in costume; 23 shooters and 7 RSOs/Coaches. 2<sup>nd</sup> Annual Turkey shoot will be held on 11/18 with Butterballs for prizes

Three Gun - No report

Practical Pistol – 15 shooters last match; next match 11/2 with both metal and cardboard targets

Public Use – Working on putting together a RSO class for Archery; make sure Jodee is available. Work party on 11/3 – sandbags, put steps in by Public Shoot sign, wood stacked. Next date for work party hasn't been established but will be picking up wads on the B range. 2024 schedule is on the website and Dan will review for gate keeper assignments

Shotgun - 7 shooters on 10/14, next match 11/11

Silhouette – 3 shooters at last match, next match 11/19. Starting in January will move to 2<sup>nd</sup> Sunday

Biathlon – Summary May – Oct; Two beginner camps (30 people, 10w/20m ranging in age from 8-70); Four races (53 competitors ranging in age from 8-73 and about 30 new competitors)

### Old Business:

Howard requesting funds for A range roof. Bid came in at \$15,100. Contacted six companies, three responded, \$15,100, \$27,600 and one forgot to show up. Brian Palmer motioned to accept the bid.

Purchase and delivery of two conexes; Storage for donation to High Power - \$4,500 each plus tax and delivery of \$300; Howard/Ayden motioned/seconded to table. Passed

Proposal to buy new lead testing material because we need it; New equipment, probe, GPS to track; \$2,400; Howard/Jodee motioned/seconded to table. Passed
